  - Remove 3+3 Law Program
  - o Add clause that students cannot earn a General Business major in addition to another SSB major
- The proposed change is requested to allow students greater flexibility for students.

- Total credit hours will not change

Discussion: Requirement of MATH 1413 should likely be corrected to MATH 1483. Spears School will carlify whether the number should be 1483 or 1513.

# Motion was made by A. Sanogo and seconded by A. Doust to accept the above-mentioned Spears School of Business program modifications, and Instruction Council (IC) members approved.

## 2. Other

- a. C. Francisco expressed his appreciation to IC members for their efforts preparing the Spring 2022 schedule.
- b. C. Francisco thanked the individuals for their work on the Pandemic/Endemic Planning (PEP) Task Force.
- c. C. Francisco recognized R. Peaster and her colleagues in the Registrar's Office for their flexibility and contributions made not only to the PEP Task Force, but also talking offline to different groups to ensure that the actions of the Task Force were logistically feasible. The October 11<sup>th</sup> deadline is critical for units across campus, which will allow R. Peaster and her team enough time to post information as quickly as possible and to publish the schedule by October 20<sup>th</sup> allowing students and advisors an 11-day period to review the schedule and determine their plan before priority enrollment November 1<sup>st</sup>.
- **d.** C. Francisco announced that Integrative Biology is bringing in an inclusivity speaker to present inclusive activities within the classroom. The speaker is Dr. Veronica Womack from Northwestern University.
- e. C. Francisco explained that large groups of course actions will soon be sent out so that IC members will have at least ten days lead time prior to the following IC meeting. The intent is to distribute that information to department heads in order to review for possible conflicts. Hopefully the earlier submission will expedite the process and disperse the workload more evenly.
- **f.** A. Sanogo announced the requirement from Oklahoma House Bill 2396 regarding sex trafficking and exploitation prevention programs.

HB 2396 States: An Act relating to higher education; allowing certain nonprofit organizations to present sex trafficking and exploitation prevention and education programs at institutions of higher education; directing institutions of higher education to provide freshman students certain opportunities to attend sex trafficking and exploitation prevention and education programs; providing topics to be included in programs; providing program materials to students, parents and legal guardians at no cost; requiring program provider to incur costs of implementing prevention and education programs and program materials; providing for codification; and providing an effective date.

With the expectation is that this will be an opportunity for our freshman students, Dr. Denni Blum has experience in leading these types of training. Whether it be a course or module, she is willing to provide the resource.
