1. Transfer Dashboard in CDR – Cheryl Kleeman

Cowboy Data Roundup now has the Transfer Dashboard available with the following categories:

- Transfer Enrollment can be viewed by college, specialty populations, gender, first generation, engaged status
 - T1 = students with 7-23 credit hours
 - T2 = students with 24 or more credit hours but no degree
 - T3 = students with 24 or more credit hours with an associate's degree
 - Transfer Retention and Graduation Rates
- Transfer Persistence

- Transfer D/F/W Information
- Transfer Engagement currently 82 percent of our transfer students are not engaged
- Average Hours to Undergraduate Degree

A question was raised about breaking down the transfer information by campus. L. Burns explained that it can be accomplished but that particular request would need to be submitted separately.

The Transfer Success Advisory Board was created to improve the transfer student experience. The board is currently chaired by Dr. Doug Hallenbeck and Cheryl Kleeman. There are multiple committees and C. Kleeman announced that there is a need for people to serve on the committees.

2. NC-SARA Requirements for Out-of-State Placements – Chris Ormsbee

National Council for State Authorization Reciprocity Agreements has been in existence for five years with the purpose of coordinating online programs across the country. Prior to NC-SARA, if an institute of higher learning wanted to offer an online program in another state, that institution had to seek permission. For states that are members of NC-SARA, that permission is no longer required. California is the only state that does not participate in NC-SARA. There is now a requirement thru NC-SARA to notify them of all out of state placements. We are required to post information for out of state students who are in a licensure program to inform them whether our program meets their licensure program requirements in their home state. C. Ormsbee requested that all associate deans submit to her the names of <u>all licensure programs</u> so that they can be included with the renewal for the NC-SARA membership. It is Important to track NC-SARA also requires us to specify students who are placed in other states for internships, practicum, etc. C. Ormsbee will be contacting each academic college for this information.

3. Degree Works 5.0.5 Update – Blake Myers and Leslie Evans

We will be on an unsupported version of Degree Works starting in March, 2022. An update will be available after the first of the year. The audit will work very similarly to the current version but have a much nicer interactive component to it. The upgrade version is much more mobile device user friendly. We need to coordinate with other A&M institutions who are on our system to

make sure they upgrade at the same time. Directors of Student Academic Services group recommended week four of the spring semester as the most opportune time for the update for the advising community.

Support for the advisors will continue to be available. Functionality will remain the same. There is a large handful of individuals who have access to the new version and are working with it to anticipate any fixes necessary. The new environment will be released to all advisors in early December. They will have access to the old and new versions to compare side by side. B. Myers' team would be happy to meet with advising groups of individual colleges if necessary.

- 6. Other
 - High risk accommodation letters with the current high risk accommodation letters being submitted on behalf of our students, there is concern among faculty and administration regarding clarity of the letter. OSU is not a fully online

degree granting institution. Not all courses can be delivered online and keep the level of integrity with the course. There are challenges and frustrations with the pushback from families regarding the wording of the letter and the different ways in which it is being interpreted. A. Doust has drafted a letter to be used that addresses the issue with specific courses that cannot be delivered online. R. Peaster questioned when the accommodation letters are received and the drop/add issues that can cause challenges. C. Francisco explained that these accommodation letters are granted thru University Health Services. He would like to discuss the proposed modifications with the Academic Affairs administration and then develop a way to address it with UHS and Student Accessibility Services. The goal is clear communication with the students. IC members indicated their agreement of modifications to the letter. Additional information will be forthcoming.
