

## CONCURRENT STUDENT FERPA RELEASE FOR COUNSELORS

Oklahoma statute mandates that concurrent enrollment students receive high school credit by virtue of completing collegiate coursework. Specifically, 70 O.S. § 628.13.E states:

When a student earns college credit through concurrent enrollment, school districts shall provide academic credit for any concurrently enrolled higher education courses that are correlated with the academic credit awarded by the institution of higher education. Academic credit shall only be recorded on the official transcript as an elective credit if there is no correlation between the concurrent enrollment higher education course and a course provided by the school district.

The Oklahoma State Regents for Higher Education have clarified that all earned credit received through concurrent coursework is required to result in high school credit, which may be specific course credit or elective course credit, as determined by the individual high school.
