
# **MINUTES**

Members noted that they would like to see mandatory advising for TCC. Dr. Colom is wanting to hear suggestion from DSAS on ideas to improve retention and recruitment. He noted that Enrollment Management will create a transfer website and would like to offer an articulation summit workshop if that is something that DSAS would be interested in. He asked members to pick a date, time, location and suggest some speakers. Dr. Colom also discussed offering orientation courses for credit or noncredit for transfer students.

# 3. Second Major/Minor Declaration Form – Rita Peaster

Rita said that the Registrar's office is addressing student concerns with major changes being recorded on the transcripts and delays in processing information. Feedback from SIS indicates that the historical information can't be kept off the transcript. Dr. Colom said that he would pursue the possibilities of changing that limitation. Some members want all of the historical information on major changes to remain on the transcripts. Dr. Gates asked members to send her their admission requirements for second majors. Rita noted that the task force group working on the document will meet again and finalize forms. Members asked that the form be available electronically.
