10/28/10 - Denied continuation of the "N" designation, effective Fall 2011. It is noted on the online form that the course is not intended to meet the needs of students in all disciplines without requiring specialized skills and the writing requirements in the online form and syllabus are inconsistent.

2/7//11 – Denied continuation of the "H" designation, effective Fall 2011. The writing requirement in the syllabus and online form are still inconsistent.

3. Resubmission of the General Education Five Year Review of "H and H, I" Designations from Spring 2008.

**HIST 3253** – Absolutism Enlightenment 1648 – 1798, request continuation of the "H" designation, effective Spring 2011.

4/21/08 – course was denied continuation of the "H" as the course was not submitted for General Education Five Year Review for "H" and "H and I". 2/7/11 – Denied continuation of the "H" designation, effective Fall 2011. The writing assignments are inconsistent on the online form and syllabus. If the course is resubmitted, it must be as a new request.
