1. New General Education Designation Requests

BADM 2233 – Business Analytics Fundamentals, requests the A designation, effective Fall 2021. 3/26/21 - Tabled pending discussions with the College of Arts and Sciences and Spears School of Business.

4/16/21 – Members approved the A designation, effective Fall 2021.

ENGL 3190 – African Literature, request the H and I designations, one-time only, effective Fall 2021. Members approved the H designation, one-time only, effective Fall 2021.

Members tabled the I designation pending receipt of a revised syllabus inclusive of statement in the class schedule that reflect specifics on what students will learn in regard to the I requirements in order to assess that at least 50% of the course content is focused on the I designation.

4/16/21 – Members approved <u>pending</u> the one-time only I designation pending receipt of a revised syllabus inclusive of statements in the class reading schedule that reflect specifics on what students will learn in regard to the I requirements in order to assess that at least 50% of the course content is focused on the I designation. HESA 3113 – Civic Leadership, requests S and D designations, effective Summer 2021. Members denied the S and D designations due to the required prerequisites having additional prerequisites on HESA 2513 and 3013. Council noted that in order for the course to be considered in the future, the course description would have to be inclusive of some reference to the diversity component and there cannot be more than two total prerequisites associated with the course. It was also noted that the syllabus was for a graduate course HESA 5113 and there is reference to a graduate component in the course narrative, which does not meet the requirements to be considered general education.

HONR 1000 – Sex in College Culture, requests the S and D designations, one-time only, effective Fall 2021.

3/26/21 - Members tabled the S and D designations pending clarification on the syllabus of the S and D requirements, as it is not clear that 50% or more of the course is focused on present diversity issues within the United States. It would be helpful if detailed statements for the S and D could be incorporated in the class schedule in order for this to be assessed.

Courses designated "D" prepare students for engaged citizenship in the diverse, multicultural

society of the United States.

- a. Students will reflect on identity through the examination of one or more underrepresented groups (e.g. racial, ethnic, religious, social class, gender, age, disability, sexual orientation) in present day United States.
- b. Students will examine the ways underrepresented groups define and express themselves and the context in which these definitions are constructed.
- c. Students will critically analyze theories and systems of cultural, societal, political, or economic power.
- d. Students will demonstrate their understanding through written work that provides them the opportunity to enhance their writing skills; upper division "D" courses will include extensive written work.
