1. New General Education Designation Requests

BADM 2233 – Business Analytics Fundamentals, requests the A designation, effective Fall 2021. Tabled pending discussions with the College of Arts and Sciences and Spears School of Business.

EDTC 4110 – Introduction to Assistive Technologies, requests the S and D designations, one-time only, effective Fall 2021.

Members tabled pending receipt of a revised syllabus inclusive of a class schedule that reflects specifics on what students will learn in regard to the S and D requirements and to assess if at least 50% of the course content is focused on the D designation.

Members approved <u>pending</u> receipt of a revised syllabus with a more explicit breakdown of how the course meets the requirements for the S and I designations through class content and the class schedule to determine if 50% or more of the course content addresses current international culture outside the United States.

HONR 1000 – Sex in College Culture, requests the S and D designations, one-time only, effective Fall 2021.

Members tabled the S and D designations pending clarification on the syllabus of the S and D requirements, as it is not clear that 50% or more of the course is focused on present diversity issues within the United States. It would be helpful if detailed statements for the S and D could be incorporated in the class schedule in order for this to be assessed.

HONR 1000 – Travel Writing/Writing Travel, requests the H and D designations, one-time only, effective Fall 2021.

Members tabled the D designation, as it is not clear that the course meets the requirements of the D designation and that 50% of the course is focused on diversity in the United States. It would be helpful if detail statements could be incorporated in the class schedule in order for the 50% to be assessed. HONR 1133 – Place as Text Seminar, request the H designation, effective, Fall 2021. Members approved the H designation, effective Fall 2021.

LL 3633 – Language and Migration, request the S and I designations, effective Fall 2021.
