2. Industrial Engineering and Management, MS – Electronic Delivery

Last week OSU received notice that the Higher Learning Commission (HLC) requires an updated list of degree sites.

A degree site is a location where OSU faculty are physically present to deliver and students receive instruction for at least 50% of the degree requirements. It does not include courses/programs delivered by distance education.

The U.S. Department of Education recently ruled that students who enroll in courses at these degree sites will no longer be eligible for federal financial aid unless the sites appear on the list of degree sites approved by HLC.

Industrial Engineering and Management wants to offer a masters degree that is available electronically and members were given a copy of the request to review. Members agreed that they did not need to review these requests before they were sent to Oklahoma State Regents for Higher Education.

3. Online Diploma Application – Celeste Campbell

Celeste noted that the On-Line Diploma Application will be ready to implement on January 7, 2008. The new application has several new features. Only seniors and graduate students who have been coded by the Graduate College can apply. Once the student completes the online application they will receive a confirmation email. Those students who have opted to have the Buckley Flag will be reminded that their name will not appear in the commencement book unless the flag is removed. This semester the Registrar's Office is processing both paper and online applications. The student's legal name (full name as it appears in SIS) will appear on the diploma. In the past the students had the option to choose the name that would appear on the diploma. The online application will be located on the Registrar's Homepage.

4. Enrollment Management Office Open for Business – Saturday, January 5, 2008 – Albert Colom

Enrollment Management offices will be open Saturday, January 5, 2008, from 10-3 to accommodate students enrolling. Undergraduate Admissions will be contacting continuing students who have not enrolled for Spring.

5. Premed Event with Colleges – Albert Colom

Different units have been discussing the possibility of Enrollment Management hosting a premed event for prospective students in the Spring. Members asked if the event would be limited to the Stillwater campus and Albert noted that the event would be open to the OSU System and the intent is to educate prospective students of the opportunities within the OSU System in relation to other professional schools. Members asked if this was an attempt to centralize premed advising and Albert replied no. Dr. Gates noted that the Center for Health Sciences is very interested in being a part of this endeavor. Albert will keep members inform of the developments.

6. Admission Process - Albert Colom

Albert noted that new admission process is still in the approval stage and if and when approved the process will be marketed as early as March 2008 and implemented Fall 2008.

7. International Grades – Albert Colom

In the past international grades were entered into the system as pass/fail and Enrollment Management proposes changing that process to enter actual grades to reflect academic history. The proposal will now go to Faculty Council.

8. Enrollment Management Council Meeting – Albert Colom

Albert noted that Enrollment Management has put together an Enrollment Management Council that meets twice a semester and they plan to create an Enrollment Management Newsletter.

9. College Deans Tours of Texas – Albert Colom

The College Deans Tours of Texas has been cancelled for this year but Enrollment Management plan to have the event Spring 2008. Please let Albert know of a good time.

10. Other

Mark Payton asked that Instruction Council members inform individuals of the changes to graduate credit. It was requested that the "R" grade option be added to the course action form, however; only research courses are available for "R" grades. Requests for courses to be graded "R" are handled by memo through the Graduate College and Provost to the Registrar.
