1. Implementation of New Degree Plans – Gary Sandefur

Provost Sandefur noted that as a result of the recently streamlined general education requirements for undergraduate degree programs, conversations took place with key individuals, including the Council of Deans and the Oklahoma State Regents for Higher Education, to see if eligible students could move to the new 2016-2017 degree sheets to allow as many students as possible to benefit from these changes. Normally new degree sheets become effective beginning with the Fall term, but this early effective date allows Summer 2016 graduates to use the new degree sheets without waiting for a Fall 2016 graduation date. Communications will be going out this summer to these students and their degree progress could be reevaluated to see if they would graduate sooner. As a result of the early implementation of the new degree plans, efforts are underway to inform students of the possibility of summer graduation. Dr. Sandefur wanted to express his appreciation for everyone's efforts with this initiative.

2. Faculty Council Recommendation: Undergraduate Research Transcript Designation – Pamela Fry Dr. Fry noted that the documents in the handouts are the original Faculty Council recommendations asking for revisions to the Undergraduate Research Transcript designation. It was believed that the effort had not been promoted as it could have been and that the policy was too restrictive. The revisions are suggested to attempt to relax some requirements. This initiative is directed by a representative committee and overseen by the Director of Scholar Development and Undergraduate Research. Dr. Garbutt asked for consideration to blend efforts from the Honors College and Scholars Development and Undergraduate Research. Dr. Garbutt would also like confirmation on the definition of the peer review conference. Dr. Fry asked members to share some recommendations and Dr. Garbutt and Dr. Ownbey will meet with Dr. Doust to discuss.

3. Academic Integrity Forms – Candace Thrasher

Candace noted that she would appreciate members' feedback in regard to the revisions to the Academic Integrity forms. A summary is listed below:

- The Academic Integrity Inquiry form has been revised to include a statement asking that the Academic Affairs
 Office be notified before issuing an admonition.
- The Admonition Form has been revised to include instructions to notify Academic Affairs of an admonition
 and send a copy of the form to the Academic Affairs Office. The wording "violation" was changed to "penalty"
 and the signature line is to include "Facilitators Printed Name".
- The Resource List has been revised to include two new statements: 1) Records of Admonitions are kept in the Office of Academic Affairs and could negatively affect the adjudication of any subsequent violations of Academic Integrity that are reported, and 2) Multiple academic integrity violations could result in suspension from the University.
- The Academic Integrity Violation Form has been revised to include the levels of the violations in the sanction
 area. "Print Facilitators Name" has been added to the signature lines and a request to copy Academic Affairs
 has been added.

Members endorsed the revised changes.
