1. Fall 2020 SSI Update – James Knecht

Semester was completed with a successful new pilot survey. Reports will be distributed to instructors today. Batch groupings should be distributed to SSI coordinators today or tomorrow. Even with much less class experience more responses were received this fall than last fall during the normal non-pandemic time – an increase of 2.6 percent – which resulted in approximately 19% more instructor reports being created.

2. Fall 2021 Class Schedule – Rita Peaster

In October 2020, the plan for the Fall 2021 class schedule was prepared to resemble Fall 2020. However, the Deans would prefer to prepare for a more normal semester. To minimize the amount of manual work that is required on everyone's part and still maintain timely summer and fall advisement and enrollment on schedule, options for Fall 2021 class schedule are provided for discussion:

- Option 1: revert current class schedule back to the Fall 2020 prior to pandemic adjustments
 - Option 2: maintain Fall 2021 class schedule as is and manually adjust
- IC members indicated their preference to proceed with option 1. A crosswalk from the Fall 2020 CRNs to Fall 2021 will assist with the transition. Classrooms will be returned to their full capacities*
- MWF classes will resume the full 50-minute class meetings
 - Auxiliary spaces will not be utilized
 - Instruction methods will be updated - traditional, online, or blended hybrid
 - Classes will revert to the original day and time
 - Classes will revert to the original classroom
 - Instructors cannot be automatically updated
 - New CRNs that were created after May 2020 will need to be manually adjusted – approximately 450
 - OSU-Tulsa would like to revert to pre-pandemic Fall 2020, only leave the building and room vacant
 - Proposed Fall 2021 timeline:
 - The above changes will need to be made prior to January 4 so that baseline schedule can be distributed to the colleges at that time
 - Updated schedules from individual colleges will need to be returned to Registrar's Office by January 29
 - Class schedule will be published February 22
 - Enrollment will open March 22
 - R. Peaster expressed her concern with having to revert AFTER enrollment due to the human resource toll
 - The possibility of a plan A and plan B was discussed and R. Peaster will discuss with IT the possibility of capturing the alternate data for use
 - If colleges have data for the modified Fall 2021 schedule, please keep on deck just in case
 - Course deviations – no need to resubmit all of the previously approved deviations from the courses that deviate from the regular schedule
 - Independent study classes will continue as is

3. Official Class Time Schedule and TR 12:00 – 1:15 pm class meetings – Rita Peaster

Tuesday / Thursday (TTh) classes:

- a. Deans requested that we keep the 12:00 to 1:15 in the standard schedule going forward
 - i. Option 1: permanently adopt Fall 2020 in terms of TTh 12:00 – 1:15 classtime, which created a new hole in the schedule and moved everything else to be scheduled an hour later in the afternoon. Common exams on TTh will be held thirty minutes later. This option creates more coursework opportunities
 - ii. Option 2: every TTh class starting 12:30 and later will move up 30 minutes
- b. IC members indicated their preference for option 1

Motion was made by T. Wikle and seconded by R. Seitsinger to utilize the TTh class schedule which created a new class time in the schedule 12:00 to 1:15 and moved all following classes an hour later in the afternoon. Motion was approved.

4. Leadership Certificate - cross listing intro course – Jeanette Mendez

Question – do we want to give the colleges as much flexibility as possible with the courses that have leadership components for your students to then seek out this certificate. One introduction class taught by Josh Taylor – we would cross list that course across the various colleges so that the colleges would retain student credit hours. Before we go through the process of course action forms, open for discussion. IC members expressed their desire to keep the intro leadership certificate course within one college only – UNIV, due to different college fees per college and the fact that the credits follow the instructor. Once this program is approved by the State Regents, information will be distributed across campus.

5. Test Optional Pilot Proposal – Jeff Hartman

Heads up- - OSU is participating in a 5-year pilot program with the Board of Regents in a test optional admission. OSU Admissions office submitted a proposal and will be reviewed in January. Notification of acceptance of proposal should be received by February. The acceptance of this program will apply for the spring 2021 class or fall 2021 class. Cover everyone on the freshman side and non-traditional side, but not transfer students. Currently we are accepting students thru test optional admissions via an Exception. Should this proposal be accepted by the Regents, this would be standard criteria. These students would enter college through the holistic process.

Graduate Certificate in Effective Teaching in Elementary Schools (267)

Course requirement change

 - No new courses will be added and no courses will be deleted.
 - Total credit hours will not change.
